

4. Duty roster of each security personnel have to be submitted by the Agency well in advance to the office.
5. Attendance register of each on duty personnel have to be maintained everyday and should be signed by the SMP officials.
6. All details of the security personnel deployed like Postal Address, Mobile No., and Voter Identity Card etc must be submitted to the SMP Authority by the Agency immediately.
7. The agency must replace any security personnel as and when instructed by the SMP authority for negligence, disobedience, indiscipline or any other reasons assigned.
